- I understand the animals I may interact with may be untrained and unhealthy and that the behavior of domestic animals may be unpredictable resulting in serious personal injury or death, as well as extensive property damage. PFPOKC makes no representations whatsoever regarding any animal's temperament, health (including the presence or absence of diseases transmissible to humans or to other animals), age, ability, attitude, or trainability.
- Knowing the risk of handling domestic animals, I agree to assume those risks and to release, discharge and hold harmless PFPOKC, its Officers, Board Members and their families, participants, volunteers and affiliates from any and all liability, claims, damages and costs for bodily harm, personal injury, property damage to myself or others participating with me which may occur during my volunteer duties with PFPOKC arising out of or as a consequence of, any injury or damages from any activity connected . This waiver includes me, all of my family members and descendents forever from seeking any legal action whatsoever against The Pet Food Pantry of Oklahoma City, Inc. or its representatives.
- I acknowledge I have never been accused of or charged with animal neglect or cruelty.
- I understand in my capacity as a volunteer with PFPOKC, I may come in contact with confidential information. I agree to protect this information to the best of my ability and to not divulge any confidential information during or after my service as a volunteer.
- I agree to maintain strict confidentiality regarding services and personal information and circumstances of clients being served.
- I agree never to accept gifts or money from clients.
